Evergreen Day School Tuition Assistance Policy

In supporting the EDS community, Evergreen Day School provides a limited amount of financial assistance each year, subject to budgetary feasibility. Funds are awarded on a first-come, first-served basis. Tuition assistance requests are generally due at the time of enrollment application, however, if a situation arises during the school year, please contact the office.

All financial assistance information submitted by families is kept confidential, and is reviewed only by the Tuition Assistance Committee of EDS. If it becomes necessary to share this information with the EDS Board of Trustees, the body that establishes the budget for financial assistance, the same confidentiality rules would strictly apply to the Board of Trustees.

Requirements to be considered for financial assistance:

Income Requirement

To meet the income requirement, your household income must initially be at or below 100% of the State Median Income (Income Eligibility Table can be found on the Commonwealth of Mass Department of Early Education and Care website). If you or your child has a documented disability or special need, your household income must initially be at or below 100% of the SMI.
